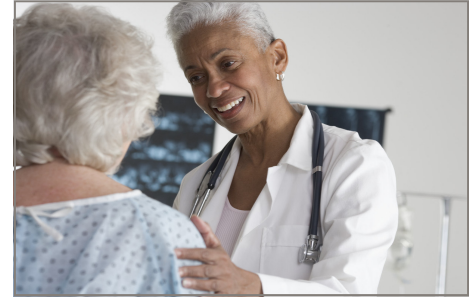


# A resource for Ohio's nonprofits.

## Member Benefits

### Regional & Web-Based Education

OANO holds more than 50 educational programs each year covering topics such as fundraising, governance, and accountability. Members receive a discount on registration fees and some programs are free for members.

### Public Policy Work for the Sector

OANO serves as a voice representing the sector at state and federal levels.

### News Sharing

OANO provides members with public policy and news alerts such as how the economy is impacting the nonprofit sector in Ohio. Members also receive a bi-monthly e-newsletter.

### OANO Annual Conference

For the past 16 years, OANO has offered an annual conference for members to network, attend multiple educational seminars, and hear from many well-respected statewide and national speakers.

### Standards for Excellence

The Standards for Excellence is an ethics and accountability code for Ohio's nonprofit sector. This program is designed to assist nonprofits in implementing best practices in nonprofit management. To that end, OANO offers educational seminars focused on the Standards (at a discount for members).

### Ohio Nonprofit Excellence Award

The Award recognizes creativity, execution, achievement, and overall excellence of a specific project or program completed by an Ohio nonprofit. Award winners and finalists are recognized during a luncheon at the Ohio Statehouse.

### Sample Policies & Procedures

OANO offers an ethics and accountability program for the sector called the Standards for Excellence. As part of this program, members have access to sample policies and procedures (Conflict of Interest, Whistleblower...) to help them save money.

### One-on-One Technical Assistance

OANO staff is here to help answer legal and regulatory questions, assist with board governance issues, and provide guidance on planning, human resource issues, and much more.

### OANO Job Board

An employment ad in a newspaper can cost hundreds of dollars. Members can post their job openings on our website for free.

### Member savings and group purchasing programs

OANO members are saving thousands by opting out of the state unemployment tax system and into our unemployment savings program. OANO members are saving on healthcare, workers' compensation and more.

Members can schedule an appointment to talk with an expert, and get advice at no charge on specific human resources, legal, fundraising, and marketing topics.

### OANO Annual Salary Survey

The report includes information for more than 70 job titles, covers compensation trends, and information of benefits such as retirement. The survey is free to those who participate. Nonparticipating OANO members pay only \$50.
